LANCASHIRE DIABETIC EYE SCREENING, THE RESTORATION

MARCH 2020 - 1ST NATIONAL LOCKDOWN ANNOUNCED

The Lancashire DESP Team cancelled all future appointments and paused the programme due to national risk stratification of Diabetic "At Risk" patients.

High risk DS and Pregnant patients continued to be invited following national guidance, with the first full "Restoration" Clinics being held on 24th June 2020.

- Work with venue leads to ensure appointment capacity for 2021, so that appointments are in place for 2021
- Ensure staffing levels are sufficient to provide full screening from mid January (recruit to vacancies)
- Ensure East Lancashire Hospitals NHS Trust, PHE and NHSEI are updated on any changes.

January 2021

All Venues now fully open to DESP, and patient numbers significantly increase in most clinics to pre-covid levels of activity (this was due to number of other community services not starting and higher than average DNA rates in clinic) – waiting rooms were able to cope with increased patient numbers

Update - June 2021 - It was the intention of DESP to run 2021 as close to a normal year as possible, to ensure that all patients delayed could be offered in enough time to meet the national target, by the end of June at the mid point of the Calendar year 45% of all eligible patients had been offered an appointment.

July 2021

Due to the lifting of restrictions because of the national vaccine roll out, Lancashire Diabetic Eye Screening fully returns to pre-covid levels of screening activity.
